The following indicates our policies concerning individuals taking the GED test.

Please read thoroughly; date and sign where indicated.

1. All applicants will be required to show positive proof of identification before being allowed to test **ABSOLUTELY NO TESTING WITHOUT PICTURE IDENTIFICATION, (DRIVER'S LICENSE, ARMED FORCES ID, ETC.) THE BIRTH CERTIFICATE, MARRIAGE LICENSE, SOCIAL SECURITY CARD, ETC. WILL NOT BE ACCEPTED FOR IDENTIFICATION PURPOSES.**
2. Any applicant who marks or otherwise damages a test booklet(s) will be required to pay the Judson ISD **\$15.00 multiplied by the number of remaining allowable usages; total charge owed may vary per individual booklet** before being allowed to continue testing.
3. Sheets of scratch paper issued to the applicant with a test are to be turned in at the time the test is returned.
4. Applicants should complete each test at one sitting without any interruptions.
5. Applicants who talk, or pass any type of information to another applicant at any time during the testing sessions, will not be allowed to continue the test.
6. A student who fails any of the GED tests may retake a test after six months **UNLESS** the teacher certifies in writing that the student can now pass a test previously failed.
7. The **\$18.00** test fee will be **forfeited** if the examinee calls to schedule for a test session and then fails to show up without having called to cancel by 4:00 p.m. on the date of the test.
8. Any defacing of ISD property will be cause for **dismissal** from the testing program.

## QUALIFICATIONS AND TESTING POLICIES FOR THE GED

1. The State of Texas requires that the examinee be 17 years of age or older. A person who turned 17 is eligible to take the GED test but must have officially withdrawn from high school **and** has the Eligibility Verification/Parent Approval for signed by a parent or guardian. (A signed letter from a parent stating that the applicant has withdrawn from high school and granting permission to take the GED is acceptable.) Anyone who has completed high school in the United States or formerly passed the GED may not be tested.
2. Identification is required of all examinees: A valid Texas driver's license or Texas Public Safety ID. Falsification of ID is subject to federal and state investigation and will disqualify the examinee from taking the GED. **You must bring this ID with you on the test day.**
3. A fee of **\$105.00** (in cash or money order) is to be paid when registering for the test. All fees are good for **1 year** from the registration date after which time no refunds will be granted. **A \$25.00 fee will be charged against any and all refund requests for cancelled registrations.**
4. **No-shows must pay an \$18.00 re-registration fee before they can be tested.** (Someone who does not come in to take the tests on the date for which s/he is registered is considered a No-show).
5. The reporting time for examinee is 4:45 p.m. **Latecomers will not be admitted.**
6. The use of dictionaries, books, tables, or any other aids is strictly forbidden. I also understand that I am not allowed to bring in cell phones, pagers, calculators, radios, tote bags, purses, textbooks, notebooks, coats, hats, hand-held electronic games, or other nonessential items to my seat during testing.
7. Time limits - Writing Skills: 2 Hrs. Social Studies: 70 min.; Science: 80 min.; Reading: 65 min.; Math: 1 hr. 30 min.
8. Proper dress is required when attending test administrations. Offensive and or abusive language is also prohibited. Attachment outlining our policy is enclosed.

### **RE-TESTING POLICY**

1. It is recommended that the examinee prepare for re-testing by studying at an adult education program or with a certified teacher. The examinee will receive a re-test letter that must be presented at the time of registration. Without a re-test letter the waiting period is six months.
2. Re-test fee is \$18.00 per subject.

POLICY ON RESPONSIBILITIES OF GED® EXAMINEES  
and  
OWNERSHIP OF TESTS, SCORES, and OTHER DATA

The American Council on Education® (ACE) is the sole owner of the Tests of General Educational Development (GED® Tests) and the responses to those tests, including all test questions, essay prompts, and essays. The GED Tests are not the property of the examinee. The test questions and essay prompts administered at testing centers are the valuable, copyrighted property of ACE. As a condition of testing, an examinee agrees to maintain the confidentiality of all test questions and essay prompts administered to him/her. An examinee may not receive any unauthorized assistance while taking the GED Tests. An examinee may not discuss specific test items or essay prompts with anyone other than the GED Chief Examiner/GED Examiner. An examinee must return all testing items to the GED Chief Examiner/GED Examiner at the conclusion of testing.

A disclosure of test questions in any form by any means in violation of this confidentiality agreement undermines the integrity and security of the GED Tests and is strictly prohibited. Any unauthorized access, reproduction, distribution, or disclosure of test questions by an examinee before, during, or after taking the GED Tests is a violation of U.S. and international intellectual property laws and treaties. Available remedies will be pursued by ACE as appropriate, which may include criminal prosecution, a civil lawsuit seeking damages, and/or canceling or invalidating the examinee's test scores and notifying entities that have received the examinee's test scores.

In addition, a number of third parties perform services relating to the GED testing program. ## PRIVACY POLICY

GED® Testing Service, a program of the American Council on Education, recognizes the privacy interests of GED examinees. GED Testing Service™ is committed to respecting that privacy and keeping examinees informed about our data privacy policies.

Except as set forth below, the personally identifiable information an examinee provides when registering for the GED Tests is not made available to third parties without the examinee's permission. An examinee's personally identifiable information includes his/her name, address, identification number, date of birth, test dates, and test scores.

1. Research. GED Testing Service and third parties authorized by GED Testing Service may access and use examinee data for research purposes, including research directed toward improving or reporting on the effectiveness of the GED testing program. Any such access to examinee information will be subject to a confidentiality requirement that prohibits the disclosure or publication of any information that allows individual examinees to be identified. Once a third party has completed services related to the GED testing program, the data used will be permanently removed from the third party's possession. Unless an examinee has indicated otherwise on the demographics form, GED Testing Service may contact an examinee to determine whether he/she is willing to participate in surveys that also are intended to improve or report on the effectiveness of the GED testing program.

2. Legal Proceedings. GED Testing Service may disclose and provide access to personally identifiable examinee information in response to a subpoena or other order in a judicial or other governmental proceeding, or as otherwise required by law. To ensure test security, GED Testing Service may also disclose and provide access to personally identifiable information in order to detect, investigate, or prevent fraud or other unlawful activity or violations of GED Testing Service testing policies.

## Understanding Your Scores

### How are GED scores reported?

Your GED test scores provide an estimate of your academic knowledge and skills in each content area as compared to that of recent high school graduates. As with any test, the scores are not intended to be a complete measure of all you can do.

For the 2002 Series GED Tests, performance on each of the five tests is reported in two ways: as "a standard score," ranging from 200 to 800, and "a percentile rank," ranging from 1 to 99.

A standard score is used to compare a test-taker's performance on a test to the performance of graduating high school seniors who took the test. The average standard score for a sample of U.S. graduating high school seniors is 500 for each test in the battery. About half of these seniors earned standard scores above 500 and about half earned standard scores below 500 on each test. Approximately 68 percent of all graduating high school seniors earn scores between 400 and 600 on the GED standard score scale. Only 2 percent of graduating high school seniors earn scores lower than 300 or higher than 700.

The percentile rank indicates the percentage of graduating high school seniors who earned scores at or below your test score. For example, if a test-taker earned a score of 510 on the Science Test with a percentile rank of 54, those numbers indicate that 54 percent of graduating high school seniors earned a score of 510 or lower.

Each item is worth one point if answered correctly and zero points if answered incorrectly; however, the number of items answered correctly is not reported.

The Language Arts, Writing Test standard score is a weighted combination of scores from Part I (multiple-choice items) and the essay in Part II.

### What scores are needed to pass the GED test battery?

To pass the five-test battery, the GED test-taker must demonstrate a level of knowledge and skill that meets or surpasses that of approximately 60 percent of graduating high school seniors.

For the 2002 Series GED Tests, the minimum passing standard set by the GED Testing Service® is an average standard score of 450 or greater across the five content area tests (a total standard score of 2250 or greater) and, in addition, a standard score of 410 or greater on each content area test. Most U.S. jurisdictions (state, province, or territory) use this passing standard requirement; however, they may set their passing standard requirement higher than, but not lower than, a total standard score of 2250 or greater and a standard score of 410 or greater on each test. Although the requirements may vary slightly from one jurisdiction to the next, passing standard requirements are typically reported as a minimum total or average standard score across all five tests and a minimum standard score for each test.

This passing standard requirement allows test-takers to "compensate" for performance in one content area by stronger performance in another; i.e., a lower score on one test can be compensated by a higher score on another test and result in passing the GED test battery. Many skills make important contributions to achievement, and it is possible for most test-takers to compensate for weaknesses in one area using strengths in other areas.

Local [Official GED Testing Centers](#) can tell test-takers what requirements must be met in order to earn a GED credential.

## **Retesting**

If you take the GED Tests and don't meet the minimum passing standard needed to earn a GED credential in your jurisdiction, you should contact your local adult education resource center or look into preparation classes or materials to help you brush up on your skills.

## **College admissions and the GED credential**

If you are taking the GED Tests for college or university admission, check first with the institution to find out the minimum scores required as well as other criteria you might need to meet for admission.

## **GED Testing Center**

### **Dress Code Policy**

Your appearance has much to do with the way you feel about yourself. Appearance also affects the way in which others respond to you and has a great deal to do with your personal success and the learning atmosphere of our test center. Because of this, Judson Independent School District has established a dress code policy for individuals seeking to obtain a General Education Development (GED) through our GED Test Center.

#### **Tops**

- Must have a finished neckline.
- Must be appropriately buttoned.
- May not be worn in any way that reflects gang affiliation, conceals contraband or creates a distraction as deemed appropriate by JISD administration.

#### **Bottoms**

- Slacks, jeans, walking shorts, skirts, dresses, or jumpers are acceptable
- Pants must fit at the waist and be properly hemmed or cuffed at or below the ankle, but not dragging the ground ("slicing" or "ragging" not allowed).
- May not be worn in any way that reflects gang affiliation, conceals contraband, or creates a distraction ("sagging" not allowed).
- Boxers, pajamas, or other sleepwear is prohibited.

#### **Outerwear**

- May not be worn in any way that reflects gang affiliation, conceals contraband or creates a distraction as deemed appropriate by school administration.

#### **Hair**

- Must be neat, clean and well groomed.
- Symbols and/or styles which are identified with gang membership, affiliation or representation shall not be allowed.
- Extreme hairstyles and/or coloring cannot be a distraction to the educational process.

#### **Shoes**

- Examinees must wear shoes that are safe and appropriate.

#### **Miscellaneous**

- Examinees enrolling in Judson ISD GED Testing program will be expected to comply with the dress code policy.
- Revealing or excessively tight garments (tops, stretch pants and leggings) are prohibited.
- Accessories with inappropriate decorations or advertisements are prohibited. This includes but is not limited to, any item that depicts the occult, sex, gang membership, death, suicide, violence, drugs or alcohol.
- Examinees are prohibited from using offensive and or abusive language while on district property.
