As the parent/legal guardian of this student, I hereby acknowledge my understanding of the terms and conditions of this transfer as noted below:

- A transfer may be revoked if the student does not remain in good standing- all nonresident transfer students must maintain the following standards:
 - The student shall maintain the standards outlined in the program in which the student has been accepted and enrolled.
 - The student shall comply with the District attendance standards and shall demonstrate academic progress that would earn promotion to the next grade level.
 - The student shall be responsible for complying with the policies and rules in the JISD Student Code of Conduct and the school rules of the receiving campus and shall be subject to disciplinary consequences as established in the JISD Student Code of Conduct.

- In the event of overcrowding at the receiving school, the neighborhood student shall be given priority in placement over the transfer student. Therefore, the District reserves the right to withdraw a transfer student based on the district's last-in-first-out procedure.

- A transfer, once approved, for an employee's child, or a graduating senior, shall remain conditional and valid only for the period extending until the end of a given school year. Parents and other persons standing in parental relation must renew their requests for transfers every year.

- A transfer, once approved, for a student who moves outside the District shall remain conditional and valid only for the semester/term.

- A student shall be allowed only one transfer by parent request during the school year.

- The District shall not provide transportation for nonresident transfer students; Transportation must be provided by the parent/guardian.

- In order to participate in UIL activities, the student must meet UIL eligibility requirements. A transfer to another campus may adversely affect the student's ability to participate in UIL sanctioned extra-curricular activities.

The District reserves the right to invalidate an approved transfer which has been based upon false information knowingly submitted by the parent/guardian in the application process.

Confirmación de Transferencia Fuera del Distrito

Como padre / tutor legal de este estudiante, por la presente reconozco mi comprensión de los términos y condiciones de esta transferencia como se indica a continuación:

- Una transferencia puede ser revocada si el estudiante no permanece en buen estado; todos los estudiantes de transferencia no residentes deben mantener los siguientes estándares:
 - El estudiante deberá mantener los estándares descritos en el programa en el que el estudiante ha sido aceptado e inscrito.
 - El estudiante deberá cumplir con los estándares de asistencia del Distrito y deberá demostrar el progreso académico que le otorgaría el ascenso al siguiente grado.

Los padres y otras personas que están en relación parental deben renovar sus solicitudes de transferencias cada año.
- Una transferencia, una vez aprobada, para un estudiante que se muda fuera del Distrito deberá ser condicional y válida solo por el semestre / período.
- Se permitirá que un estudiante solo sea transferido por solicitud de los padres durante el año escolar.
- El Distrito no proporcionará transporte para estudiantes transferidos no residentes; El transporte debe ser proporcionado por el padre / tutor.
- Para participar en las activaciones de UIL, el estudiante debe cumplir con los requisitos de elegibilidad de UIL. Una transferencia a otro campus puede afectar negativamente la capacidad del estudiante para participar en actividades extracurriculares aprobadas por UIL.
