
As you know this week, San Antonio Mayor Ron Nirenberg issued a third public health emergency and prohibited gatherings of more than 50 people. Therefore, and because of the rapidly evolving nature of this situation and out of an abundance of caution, Judson ISD is joining other San Antonio area districts in extending our closure of campus classrooms through Friday, April 3. Our plan is to resume school on Monday, April 6th but we will continue to monitor any latest developments with COVID-19. Parents should begin, if you have not already done so, to plan for long term closures of schools.

Through this time frame we will continue to offer curbside meals for our students for breakfast and lunch at designated locations around the District. We are also working to implement remote instruction and also provide hard copies of work assignments. This week we will be working on developing the instructional component and you will be receiving information from your child's campus.

We will continue to provide regular updates on our website, social media channels, and through our email messaging system. In an effort to provide you speedy communication, please make sure you can receive text messaging from Judson ISD by texting "YES" to the code 875-69.

Once again, I want to thank you during this unprecedented time. The community of Judson ISD has come together to show positivity and commitment to taking care of each other. We want you to know that our students' safety and well-being are our top priorities. We understand that these developments have put a strain on your family, but we continue to be committed to educating your children. We will get through this by working together. Thank you for your patience and understanding and for your support of Judson ISD schools.

Muchas gracias por su paciencia y apoyo mientras continuamos monitoreando activamente los acontecimientos relacionados con el coronavirus (COVID-19) en conjunto con funcionarios de salud pública locales y estatales, y los Centros para el Control de Enfermedades (CDC).

Como saben esta semana, el alcalde de San Antonio, Ron Nirenberg, emitió una tercera emergencia de salud pública y prohibió las reuniones de más de 50 personas. Por lo tanto, y debido a la rápida evolución de esta situación y por una abundancia de precaución, Judson ISD se une a otros distritos del área de San Antonio en extender nuestro cierre de las escuelas hasta el viernes 3 de abril.

También estamos trabajando para implementar instrucciones remotas y también proporcionamos copias impresas de las asignaciones de trabajo. Esta semana trabajaremos en el desarrollo del componente de instrucción y usted recibirá información de la escuela de su estudiante.

Continuaremos proporcionando actualizaciones periódicas en nuestro sitio web, canales de redes sociales y a través de nuestro sistema de mensajería por correo electrónico.
